He is also a **Fellow Member of the** Institute of Chartered Accountants of India (**ICAI**) as an **All-India Rank Holder**.

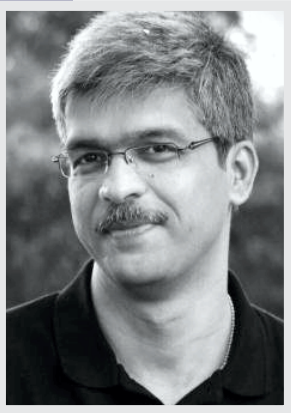
