We are investing heavily in smart services, as part of the vision of UAE's leadership, to support private sector development. One of our most visible achievements is that the country's ranking in the Global Innovation Index has consistently gone up and in 2018 we were ranked 38^{th} globally and 1^{st} regionally, up from 41^{st} position in 2016.

All this has been possible due to the leaders of our country. Leadership is the foundation for making ideas a reality. An innovative leader does not even need to be the person who creates the idea behind an innovation. Often, they simply recognize a great idea — and envision the path that leads to that idea's becoming a reality. An innovative leader also challenges the status -quo and doesn't rely on the safe and comfortable path but on their future vision to make decisions.

To one's credit, UAE's leadership has played an instrumental role in creating an innovation fueled economy and their persistent commitment is clearly evident from the country's ambitious 'Vision 2021' and 'National Innovation Strategy' that was launched in 2014. As part of this strategy, the UAE government identified 7 priority sectors including Renewable Energy, Transport, Education, Health, Technology, Water and Space. Further, the government also plans to roll out 30 major initiatives within a three-year period, in the optic of fostering innovations in these sectors.

The world of technology is moving at a very high speed, where big data and Artificial Intelligence drive product development and marketing. The private sector here is still at the nascent stage but we are making strategic investments to introduce these technology enablers.

As a result, we have witnessed new products and services entering the market and this encourages us to continue our work. One way of ensuring that this process doesn't slowdown is to do "innovation through acquisition". Acquiring companies that are leading the innovation race and learning from the best is one of the best enablers for a country.

And the UAE economy is a testament to that. Today, we are working on improving our investment environment and offerings by completing a number of mega infrastructure projects. For instance, we have allocated more than USD 27 billion towards expanding our airports. The UAE continues to leverage its strategic location and advanced infrastructure to develop its import and export capabilities and be a gateway to 2.2 billion consumers in the Middle East region and a solid base for businesses to tap into European and African market

One of the biggest advantages of our developed investment environment is the ability to offer a uniquely secure and politically stable environment. A number of international organizations have their regional headquarters in the UAE. I don't need to emphasize about the Indian businesses present in the country, as you all know the success stories.

Only companies that are constantly challenging themselves are able to come up with new way of doing things. To add to this, customers these days have very high expectations and a short attention span. Therefore, innovation cycles are becoming shorter and require companies to constantly build their capabilities to be commercially viable. Therefore, a forward-thinking leadership, with an eye on the future is imperative to constantly stay ahead of the curve.

One must remember, that companies who seek and act upon opportunities to innovate in a competitive, uncertain and dynamic business environment will not only survive the tough times, but also grow in the face of challenges.
