This will also improve macroeconomic factors like sustainable growth etc. All stakeholders: Govt, SEBI, IOD and most importantly women want women involvement in boards, Gov: min 1 woman director on boards of listed companies, crèches are now mandated in companies >50 employees, paid maternity leave is 26 wks. The participation of women in boards increased to 14% from 4-5% and is at the global avg finally. But we have a long way to go vs Norway etc., In world economic forum at Davos which she attended last week, all co-chairs were women from diverse backgrounds, women participation was ever highest at 21%, world leaders like Modi ji and Justin Trudeau spoke about inclusive growth, Heritage involves women in the most critical part of ops - milk procurement. She briefed Heritage CSR activities benefit rural women directly nutritionally and financially. She said Heritage have won the CSR award given by FTAPCCI and also they had won the excellence in corporate governance award 2 yrs in a row. She told Heritage have 50% independent directors including an independent Chairman and she says proudly that Heritage have 2 women directors. Ms. Brahmani told we need to at least aim for 20% women board participation. We need to focus on education. Companies should have double bottom line (profit and social impact incl gender gap), Ms. Brahmani has appreciated IOD in doing wonderful work. It conducts several master classes and workshops across India like this one to fructify the vision govt and stakeholders, To sum up women can achieve great heights. All we need is opportunity, skills which are being created now!!
