Independent Directors (ID)

Independent Directors serve as an important Institution of corporate governance contributing significantly at the boards by bringing a diverse set of skills with an independent judgement on the significant issues. Independent Directors need to act as the custodians of good governance by discharging, monitoring, and advisory role effectively. They need to act in the interest of the company and the interest of all stakeholders.

The factor that strengthens the corporate governance framework the most, is the role played by the Independent Directors. To bring transparency and integrity to corporate boards, Independent Director's conduct is seen as the benchmark. Independent Directors are seen as the catalyst of change, who bring value to the board and provide the right balance with their diverse and cross-functional professional skills

Corporate scandals like Satyam, Kingfisher Airlines, ICICI Bank, Jet Airways, & IL&FS have shown failure of checks and balances vested in the Independent Directors. ID are liable to

face both civil and criminal charges as liability. A total of around 800 IDs have annually resigned in India, during the last 2 years.

The rules of ID are applicable to all listed companies and unlisted companies with more than Rs.10crores as 'Paid up capital', who are required to have at least $1/3^{\rm rd}$ of the directors on the board as independent directors.

Independent Directors Databank

The Ministry of Corporate Affairs, with the objective of strengthening the institution of Independent Directors under the Companies Act, launched the Independent Director's Databank in accordance with the provisions of the Companies Act, 2013 and the rules made thereunder.

Ministry of Corporate Affairs (MCA), Government of India has authorized Indian Institute of Corporate Affairs (IICA), notified under sub-section (1) of section 150 of the Companies Act, 2013 to create and maintain an online databank of Independent Directors, under the Companies (Creation and Maintenance of Databank of Independent Directors) Rules, 2019, and the Companies (Appointment and Qualification of Directors) Fifth Amendment Rules, 2019.

Objectives:

- Create and operate a verified databank of existing and aspiring Independent Directors.
- Provide a platform to self-assess the understanding and knowledge on various topics of corporate governance, regulatory and compliance framework, board essentials, board practices and other important areas.
- Provide a platform to companies requiring to appoint Independent Directors to search and select from databank of existing and aspiring individuals, by using variety of search criteria.

Launch of the Databank

The Databank was launched by Mr. Injeti Srinivas, Secretary Ministry of Corporate Affairs, on O2nd December, 2019, and can

be accessed at www.mca.gov.in or www.independe ntdirectorsdatabank.in. A detailed handbook was also released by MCA, which includes objectives, empanelment and registration process, and available knowledge resources. The handbook is also available on https://www.independentdirectorsdatabank.in/pdf/handbook/Handbook-v15.pdf. Dr. Niraj Gupta, Head-SoCGPP, IICA has been nominated, as the Nodal Officer-IICA ID Portal.

Independent Director Empanelment Process

The 'Databank of Independent Directors' provides a total list of Independent directors, by way of empanelment of existing Independent Directors as well as the professionals, with/without DIN, aspiring to become independent directors. The ID Portal shall have a pool of qualified "Board Ready' Independent Directors. This will keep a check on frivolous appointments.

As per the Companies (Appointment and Qualification of Directors) Fifth Amendment Rules, 2019, every individual whose name is included in the databank shall have to pass an online proficiency self assessment test conducted by the institute, within a period of one year from the date of inclusion of his name in the databank, failing which, his name shall stand removed from the databank of the institute. Rules have further provision for exemption from this test based on the certain conditions which will be duly calculated and notified to the empanelled Independent Directors well ahead of the test is made available on the databank.

This online proficiency self-assessment test is to be based on multiple – choice questions, covering all the areas relevant to the functioning of Independent Directors, such as Companies Act, Securities Law, Basic Accountancy and Board Practice related topics. The qualifying percentage for online proficiency self-assessment test in 60% pass marks. The performance of those taking the test, have to be disclosed by the company in their 'Annual Report'.

IDs who have served 10 years or more as a director/ Key managerial personnel are exempted from proficiency test and can be directly enrolled in the ID list.

The registration process has been specifically designed to be simple, and is divided into three simple steps:

- I. Log in through the user account on the Website of the Ministry
- ii. Upon 'log in', the user will be directed to the Databank
- iii. Choose one of the 'Subscription Plans' to access the e-proficiency assessment modules:

A. Register/Login to MCA Portal @ www.mca.gov.in

- Go to "ID Databank Registration" section under "MCA Services" and click on "Individual Registration"
- · Enter DIN/PAN/Passport details and click on "Submit"
- Enter email ID, mobile No., and country-code and click on "Send OTP"
- Enter OTP & click on "Verify OTP"

B. Redirect to Independent Directors Databank

C. Select your privacy options and review your profile

- Select Subscription Plan and Pay Fee to complete the empanelment process
- Download the invoice and registration certificate for future reference

D. Explore options for online proficiency self-assessment test

- Start date for online proficiency self-assessment test: **March 01, 2020**
- Start date for corporate access and search facility:
 March 01, 2020

As per the notified rules, all existing Independent Directors are required to register themselves in the databank within 3 months from 01 December 2019. They are also required to pass a basic online proficiency self-assessment test, which will available from March 2020 onwards, within 12 months thereafter. The Databank is expected to become a comprehensive repository of both existing independent directors as well as individuals eligible and willing to be appointed as Independent Directors.

Corporate Access to Data Bank

The Independent Director's Databank contains names, addresses, and qualifications of persons who are eligible and willing to act as Independent Directors. Databank of Independent Directors aims to provide single-point access to the corporates to search Independent Directors as per their needs and criteria.

Mandatory Requirement

To register your company on the Independent Director's Databank, you should first register on www.mca.gov.in

- Go to "ID Databank Registration" section under "MCA Services" and click on "Corporate Registration"
- · Redirected to Independent Director's Databank
- Access and search the profiles of Independent Directors by using several options Shortlist and download profiles
- Carry your own diligence while selecting and appointing independent directors from the databank

Role of Institute of Directors (IOD)

IOD as 'Strategic Knowledge Partner' with IICA

In landmark collaboration on the November 25, 2019, 'The Institute of Directors' signed an agreement with The 'Indian Institute of Corporate Affairs', Ministry of Corporate Affairs, Government of India forming a

strategic alliance as 'Knowledge Partner', for skills development of Independent Directors.
